PRIVACY MATTERS TO US

In order for us to disclose any of your medical and billing information, you will be asked to complete a Privacy Notification Form.



PRESCRIPTION INFORMATION

We request all patients bring an up-to-date list of all prescriptions, supplements, and over-the-counter medications you take to every appointment. Please keep us informed of your pharmacy. When requesting refills, please allow up to three business days. If you haven't been seen recently by a provider, an appointment may be necessary prior to a medication order or refill.

Jennie Stuart Medical Group does not routinely order or manage chronic narcotic pain medications, so you may be required to obtain these medications through a pain-management specialist.

Any and all routinely prescribed controlled medications, including narcotic pain and benzodiazepine medications, will require you to agree to and sign a Controlled Medication Agreement, as well as agree to periodic drug screens, as required by the state of Kentucky and the Drug Enforcement Agency.

We have elected to follow the FDA warnings of combined opioid and benzodiazepine use. We will work with any patient who takes these medications to find a safe and healthy treatment plan, utilizing specialists if needed.
